We introduced the upcoming retirees to the RTA mandate and encouraged them to become involved. Some of the topics included the low cost of \$2 monthly for RTA membership, three newsletters throughout the year, our work with Atlantic and national retired teacher associations, curling bonspiel and golf tournaments, and the AGM. We are so fortunate to have voting members on the pension and insurance committees. The RTA continues to advocate for all seniors, especially on issues related to health and wellness. On page 8 you will see a letter from ACER-CART president Bill Berryman re the federal dental plan. You might recall that our last newsletter had information on this as well. There have since been some new developments.

Last month, in an interview with *Island Morning*, PEI Dental Association president Dr. Brian Barrett expressed concern about the amount of paperwork involved in the program and the fees it was offering to dentists—not comparable to actual charges. He also revealed that 90% of dentists in PEI were not willing to sign up.

Since then, a number of changes have been made. There have been efforts to clarify eligibility and costs. Eligibility depends on not currently having access to dental coverage (unless you opted out of a plan before Dec 11, 2023 and can't opt back in, in which case you may be eligible); initially upon age; and upon family income (currently under \$70,000, or \$70-\$90,000 with a co-pay.) Dentists no longer have to sign up, but may simply bill Sun Life for services rendered. There may be a co-pay for the client.

Dr Barrett is optimistic that these changes will entice more dentists to become involved.

More discussion was held on the confusion around the federal dental program.

- a Young Leader award to one graduating student in each high school in the Public Schools Branch (PSB), one student in the Commission scolaire de langue francaise (CSLF) West, and one in the East; and

- a \$2000 scholarship for a graduate of an Island high school who is entering a BEd or MEd program as a full-time student at a university with a recognized program in those areas of study. See the PEIRTA website for more details.

The PEIRTA has entered into an agreement with the Community Foundation of PEI to administer the \$2000 BEd/MEd scholarship. Three RTA members—-Kimball Blanchard, Judy Hughes, and Anne Marie Muise- were appointed to sit on a committee to make the selection.

The role of the patient navigator is to ensure that you connect with the right resources and information to help you. The navigator can help ensure that you access the most appropriate service(s) for your health care needs.

The patient navigator works directly with patients, their families, caregivers, health care providers, and other individuals or organizations that provide patient services and supports in PEI.

They can

—work with health care programs and providers who can support you;
—help you find and access community resources;

— help coordinate health care services you require; and

— answer questions you have about the health care system.

The patient navigator **cannot** offer treatment suggestions or adjust wait times for procedures or the Patient Registry.

Update~by Dale Weldon, Johnson Inc.

You asked and we listened. We understand that some members have expressed concerns about the Johnson telephone system and walk-in service. We are pleased to inform you that there have been several high-level conversations between the PEITF and senior management at Johnsons, and they have put an action plan in place to deal with our concerns.

First, Johnson has agreed to implement new local and toll-free phone numbers that will be exclusive for PEITF members. As well, they are revamping the options once you call, so that there will be fewer choices and the descriptions will be clearer. Please note that for any calls concerning prescription drugs or out-of- province travel insurance claims, you will be transferred to Medavie Blue Cross once you make that choice. Any calls for extended health care or dental will be transferred to Johnson Inc.

Since there will be new telephone numbers, there will be an adjustment period, and it will take a little longer to implement.

From a walk-in service perspective, the newly hired receptionist is receiving more intense training, and an experienced staff person will provide side-by-side support. Some of the in-office team will be spending less time on the phones which will improve the capacity for personal service in the office.

Another exciting service en-

hancement is the introduction of internet banking for making premium payments. This mostly applies to active members on leave, but in case you need to make premium payments other than through pension deduction, you will not have to visit the office to do so.

Prince Edward Island Teachers' Federation

June has arrived and with that comes the end of the 2023/24 school year. An end to a school year that for me was like no other that I have experienced in my career. Until this year the main focus for my job was students, staff, and the school community. As President, my focus has narrowed slightly, and as spokesperson for the PEITF the majority of my time is spent highlighting the great things teachers are doing in our schools and working to improve the conditions that they teach in. It has been busy.

Recently you may have noticed an uptick in the PEITF presence in the media. We have been making an effort to highlight a couple of issues.

First, a looming teacher shortage that will soon be upon us if steps are not taken to ward it off. In all provinces and territories there are teacher shortages in French Immersion,

French first language, guidance, music, and high school science. Of bigger concern may be the number of teachers who are considering leaving the profession and the fact thatfewer young people are applying for education programs at our universities. Teacher recruitment and retention strategies will be critical moving forward.

The second issue of major concern is working conditions. This issue directly relates to why teachers are considering leaving the profession. Increases in inappropriate classroom behavior and violent incidents, lack of respect for what teachers do, and class composition issues make it difficult for teachers to do their work. Throughout the upcoming bargaining process we are planning to make these concerns the main focus of our talks.

In a previous newsletter I talked about our Course Correction Campaign. The first phase throughout the year was meant to highlight the issues mentioned above, and now we move into the second phase of the campaign with an emphasis on highlighting the incredible things that our teachers are doing in Island schools. We do not want to forget

that teachers are doing an exceptional job under trying conditions. The campaign has raised awareness of our issues and has successfully gottten people talking about the teaching profession.

Although teachers have many concerns in today's classrooms, you are well aware that there have always been issues facing teachers as society continuously evolves and changes. Teachers have been working on the front lines for change for many, many years. We have overcome challenges in the past and I fully expect we will find solutions for today's issues as well. The following letter was sent to Prime Minister Trudeau, Deputy Pm Freeland, party leaders, and federal ministers Mark Holland (Health) and Seamus O' Reagan (Labour and Seniors) from Bill Berryman, president of ACER-CART

Re: The Canadian Dental Care Plan (CDCP) Access Rules and the implications for low-income retirees

Dear Prime Minister Trudeau: Canadian retirees are grateful for this expansion of the Canadian Dental Care Plan; however, our members and other retirees are struggling with the current access rules that are causing unfortunate confusion and consequences for those with the lowest incomes. I write this letter on behalf of the 88,234 members of ACER-CART (L'Association canadienne des enseignantes et des enseignants retraités, The Canadian Association of Retired Teachers) regarding this recent implementation of a national dental program.

While most retired educators have access to dental plans, some retired teachers with very small pensions have declined coverage because their low retirement income makes enrolment in the dental plans unaffordable.

Under the current rules, two people with identical financial circumstances may be treated unequally. One person with access to a dental plan may be denied coverage while another person without access to a dental plan will be accepted, without apparent reason.

Moreover, individuals who opted out of a dental plan before Dec. 11,

2023, may be eligible while equally needy individuals that didn't know about this arbitrarily and retroactively imposed date are not eligible.

We would ask that the access rules be reviewed. A more appropriate, transparent, and defensible criteria for enrolment would be an acceptance into the dental plan based only on income and wealth. Canadians have always supported programs that subsidize low-income individuals. The current criteria do not do that fairly. Please reconsider this aspect of the rules and make the changes necessary to meet the needs of those it was designed to serve.

PEITF Travel Insurance

Our out-of-province travel insurance plan has a 90-day medical stability clause. This means that if you have a pre-existing medical condition, it must be considered medically stable for 90 days prior to your departure date if you are to be covered in the event of a medical emergency related to this condition while you are travelling.

A pre-existing condition is considered stable if the member, in the 90 days before the departure date, has not:

- Been treated or evaluated for new symptoms or related conditions;
- Had symptoms that increased in frequency or severity, or examination findings indicating the condition has worsened; .
- 3. Been prescribed a new treatment or change in treatment for the condition.
- 4. Been admitted to a hospital for the condition; or
- 5. Been awaiting new treatments or tests regarding the medical condition (does not include routine tests).

Number 3 generally does not include reductions in medication due to mprovement in a condition, or regular changes in medication as part of an established treatment plan—but each case must be reviewed individually. Call Medavie Blue Cross at 1-800-667-4511, Travel Department, for clarification if you are planning to travel outside PEI.
